UNION COUNCIL ELECTIONS 2019

Nominations for Representatives to the Union Council will be opened as of **Friday, April 26th, 2019.** Details of the election procedures together with a list of the Nominees will be sent out following the closing date of nominations on **Thursday, May 9**th, **2017 at 17:00.**

The following applies:

Nominations received after the closing shall not be entertained. Only members in good standing of the Association may place names in nomination or be nominated. A member may only nominate one (1) nominee for each Executive Officer position, Standing Committee Chair, or for Chief Steward/District Head.

Nominees for Chief Steward/District Head must work on the campus they wish to represent and have agreed in writing to serve if elected. Nominees for a Standing Committee Chair or Executive Committee Officer may be nominated by members from the three campuses and there is no restriction in terms of which campus they work on.

Nominations for Chief Steward/District Head must be proposed by five (5) members in good standing from the campus they will represent and who shall have signed the nomination form and have identified themselves by name and McGill ID #.

Nominations for Chair of a Standing Committee must be proposed by five (5) members in good standing from any campus who shall have signed the nomination form and have identified themselves by name and McGill ID #.

Nominations for Executive Committee Officer must be proposed by ten (10) members in good standing from any campus who shall have signed the nomination form and have identified themselves by name and McGill ID #.

It is the candidate's responsibility to ensure that nominations are made by members in good standing of the Association only. If in doubt, obtain more than the required signatures.
